Call to order at 6:32 by Janet Smerud, Booster President

First issue is the board is currently without a parliamentarian so for this meeting an acting parliamentarian is designated by the Board. Christine Smith volunteers and is appointed for the course of the meeting as acting parliamentarian.

Treasurer's Report (Michelle Hernandez):

Michelle spoke of the Budget and Financial Reports. She passed out financials and reported on beginning balances, income, expenses, and ending balances. See complete financials (ask Michelle for them as attachment).

Beginning balance as of 2/23/2023: \$39,509.10 Income of \$4,440.92 Expenses of \$8839.34 Ending balance as of 4/20/2023: \$35,110.68

No questions are asked on the budget. These financials will be finalized.

Additional financial reporting:

Update on Texas Comptroller query. After last meeting it was bought up that there is an open account with Texas Comptroller for previous booster club. Michelle Hernandez was made aware of the account and at this meeting Nancy Luleff passed on the information she had regarding account closure to Janet Smerud and Michelle. This will be added for an update at the next booster board meeting.

Question is asked do we need to file the sales tax report. Michelle Hernandez confirms yes we do, and she has already filed it prior to the due date so we would be able to get a discount.

Parliamentarian: Charity Barth will be stepping in as the interim parliamentarian until the end of the year. The Board will appoint her as the interim parliamentarian. Michelle Hernandez makes a motion to accept her through the end of the fiscal year, Julie Heuer seconds, and the board approves her as the interim.

Committee Reports

Nominating Committee:

- Nancy Luleff Presents the Slate to the group consisting of:
- President (Janet Smerud), VP (Christine Smith), Secretary (Julie Heuer), and Treasurer (Ingrid Schwindinger)
- Previous directions included confirming the interest of parliamentarian and at this time the Nominating Committee is recommending Charity Barth be considered for the spot next year as well.

Corporate Liaison (Michelle Hernandez reported):

- McAlister's Bite Night was reported on last time, with income of \$52.44
- Handel's Ice Cream Bite Night occurred since last meeting with no income (\$0) since only two people said they were with Marcus.
- Froyo-Joe coming up
- Discussed Bite Nights not very profitable but are free money
- Discussed status of the Sports Team Opportunities where we could make money doing concessions at sort/concert venues. We don't know a possible take-away yet so Janet will continue to follow-up to get more info so we can decide if this is an opportunity we want.

Publicity (Sarah Brown):

- Keeping with Smug Mug due to higher costs elsewhere
- http://marcusaquatics.net/ is up and running now -- we had the domain and are finally using it

Hospitality: No Update

Team Building:

- Deferring event to the 2023-2024 year. Discussed that we should give the team 4/5 options and the team can vote on it.
- Castlewood has space at the club house end of summer to book a party for before the start of the year
- Brandon will look at dates to determine which dates works best. Probably a 3-hour gathering. Janet Smerud will look at Aug 4th, 11-2 or 2-5) and connect with Coach Conrad (Castlewood contact). Back up option suggested to contact Lantana if Castlewood is already booked.

Bylaws Committee:

- Committee not in attendance so Michelle Hernandez reports changes made to address "mandatory" wording. The changes were to Article V Membership and Dues, stating "Membership shall be open, without discrimination, to any guardian who is in the Marcus High School Aquatics program and has paid their annual membership fee."
- These changes are reported today and available for review for 20 days.
- Discussed this timing and need for presentation of nominations and to reduce parent burden we are going to move the next General Meeting to Monday, May 15th 6:30 and at that time seek approval of the bylaw changes and the board elections.

Lead Reports:

No swim or dive update tonight.

Water Polo (Nancy Luleff):

- Upcoming Fundraiser weekend of April 28-29. Southwest Zones will be at two pools. Zones taking
 care of admissions but we are going to run parent volunteers and student volunteers, being reimbursed
 for hospitality. Janet Smerud will follow up on process for purchasing/reimbursement for hospitality.
 We will receive 30% of profit (other 40% to Zones, 30% Maverick)
- We will creating new google form for new members so next year's athletes can sign up now to be contacted over the summer for activities and information.

Coaches Report:

- Water Polo alignment: Jesuit moving out and South Grand Prairie is moving in
- Aug 17,18,19 will be first tournament varsity only, 6 games over 3 days
- Other options (Jesuit, Highland Park tournaments) may be possible but undecided

Senior Night: No Update

Banquet: Discussed if we had feedback or should do the same next year. Everyone liked the location but feedback on the food was mixed so we suggest looking for different food.

Old Business:

- TISCA -- payments made out to Flower Mound and Lewisville per report but we are still short. If we
 receive money from schools who haven't paid yet (\$260 outstanding) we will complete those
 payments.
- Kyle Tilley -- check cut to LEF
- Districts paid out to Flower Mound and Lewisville
- Region is not paid out as we still have several schools outstanding (from 2 districts)

New business:

Financial Reconciliation Committee: We will need to establish a financial reconciliation committee. This will have 3 people and 1 alternate for to review books. At year end, Michelle Hernandez will file taxes (June 30th), and then within 30 days prepare and give books to committee for reconciliation.

Spirit wear: Keeping open year-round. Let's set up before water polo and get ahead by setting for 2023-2024. Design ideas and requests accepted.

Upcoming events:

April 22 – Water Polo Game hosted by Flower Mound

April 29-30 – Southwest Zone Spring Champs

2023-2024 Team Registration:

Discussed plan to open registration early this year so that people can pay dues before school year starts.

To do list prior to opening includes determining dues for next year based on this year's financial information.

Feedback from parents (both at this meeting and reported by others) was that the webstore is too complicated. Having to use team unify and the webstore for registration and payment is a challenge.

Questions was asked if we can move back to Team Unify for both registration and payment. Consensus is the only thing not on Team Unify is payment and people didn't like going to the Team Unify for registration and then having to go to the Webstore

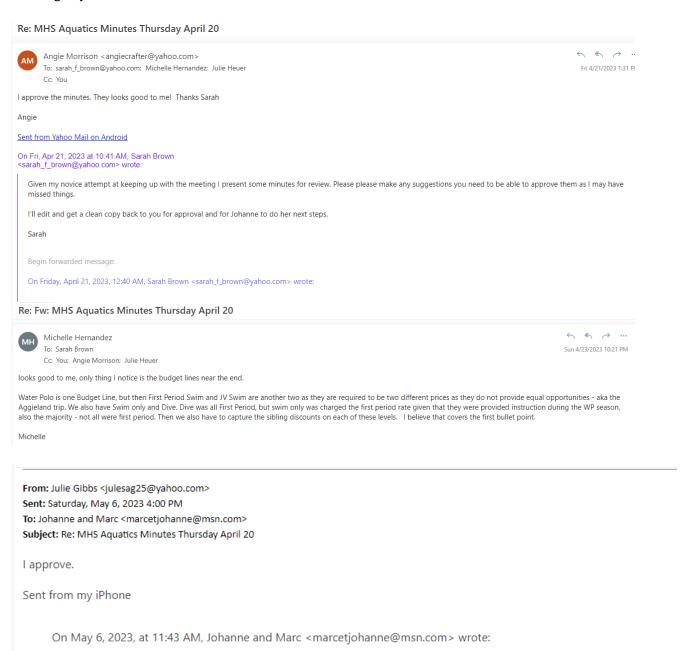
Janet Smerud will investigate what we would need to do to move to Team Unify for both. Nancy Luleff volunteered her previous team unify experience to help.

Michelle Hernandez discussed financial implications of changing platforms and early registration:

Water Polo is one budget line

- Swim has two budget lines First Period Swim and JV Swim are another two as they are required to be two different prices as they do not provide equal opportunities, such as the Aggieland trip, which is offered to Varsity (1st period) only
 - Money needs to be allocated to the correct place
- Processing fees need to be mapped to a bucket and captured (similar to how we manage transaction fees now)
- We would need to set up Escrow lines in the financials so that we could keep next year's money separate from this year and then move to the proper budget next year
- Registration must be closed when the books are closed and reconciliation is happening
- Time is needed to close books so registration would need to end ~June 15th to allow adequate time to prepare end-of-year
