Michelle Hernandez:

- Does not reflect a deposit \$46,403 from Swim & Water Polo due to the need of an approved budget for the new organization
- Ince budget is approved, this deposit will reflect at the next board meeting
- Michelle is required to read line-by-line for the final approval
- Items that were explained -- cancellation and modification of services:
 - Changed PO Box to USPS Box
 - Eliminated the QuickBooks expenses
 - Changing the storage unit
 - More items to come as the season runs
- JV water polo team is not supports by the district we will need to amend the budget at the next meeting due to additional costs (spoke of bus costs)
- Parents asked questions on what spirit wear is included for water polo and swim & dive
 - Swim & Dive: suit (every year), jacket/sweatshirt (every year), caps (every year), t-shirt (every year), backpack (one time during aquatics tenure)
 - Water Polo: suit (every year) and jacket is optional and purchased by parents
- Applied for our sales tax permit
- Need a \$15,000 beginning balance for next year due to having funds to purchase student gear before season commences prior to acquiring all student fees – we need a cushion
- Aquatics must pay the Texas A&M trip forward this year compared to previous years where
 Athletics would invoice later -- we will eventually receive a refund from Athletics
- Higher budget on Banquet due to large graduating 2024 class will be purchasing ahead to avoid lack of funds next year

- Swim & Dive Scholarship payment of \$3,059.63 to endow a 4th scholarship, which will allow four \$500 scholarships
- Some budgets increased from last year due to coverage on inflation: food, hotel costs
